When we implemented the Urban Archery, when I was on the board, we did that to give hunters the right to have the extra hunting season. It is not a firearm capability, it is a crossbow capability. It is safer to use a crossbow than it is to use a firearm. I hunt in Glen Alpine with a crossbow, not a firearm and as a hunter I don't want it. Don't want it in my community.

 - -Nicole Benfield I am here to reiterate what the past three people have said. As well as my brother and my neighbor here, we have kids that run up and down Linville Street, Lail Road and putting a gun law to where we can shoot, a stray bullet has no eyes. My son or my nephew could be walking on Lail Road and a stray bullet could hit them, and their only 10 and 11. And I'm sure everyone understands that kids are going to play. They do not know property lines, they will play and this is not an ordinance that needs to pass. We don't need to pacify one person and put everyone in danger.
 - **-Jody Lewis-** I'm opposed to it too. Because of the school up here and the kids. Everybody here knows that a high-powered rifle can travel 2800 to 3200 feet. Once you send it, you can't bring it back. Even after it hits the animal, what's that bullet going to do. You have to factor that in. I have never heard of a hunting accident where a person was killed with a bow. I haven't went online and gotten any stats, but I am 50 years old

and have never heard of anyone getting killed by a bow, it's always a bullet. Think about that.

-Travis Benfield- I do not want to see this passed, the firearm discharge in the limits of Glen Alpine and I hunt. Main reason is, I have a crossbow, shooting 80 feet at 330 feet per second. There are more people in the woods hunting with a gun than with a bow. It's harder to kill a deer with a bow. Takes more confidence, more will power. This gun stuff is too easy. I've got kids, little ones. I am a victim of gun violence. I don't want to see an accident happen in this community and it rest on your shoulders or anyone in this room. It isn't right. I want my kid to be able to hunt and fish just like I am. Being able to discharge a firearm less than 200-300 from someone's house, it's unnecessary. I do not want it in my community because I know bad things will happen. There're too many people out here and it will be well, I don't get to hunt, I don't have the land. It's going to go back and forth, and a lot of bickering will happen. I don't want it happening when kids that are getting off the school bus or on in early morning when deer are most present. I do not want this passed and that's all I have to say
